

The 75th meeting of the Second State Expert Appraisal Committee (SEAC-II) for mining projects was held on 04th May, 2017 under the Chairmanship of Dr. Navin Chandra for discussion on the query responses submitted by the PP and the projects issues received from SEIAA. The Chairman welcomed all the members of the Committee and thereafter agenda items were taken up for deliberations.

1. Case No.4646/15 Shri Sarvesh Pratap Singh R/o Village & Post-Janardanpur, Tehsil-Rampur Baghelan, District-Satna (MP)-485001 Prior Environment Clearance for approval of Laterite and Limestone Mine in an area of 4.85 ha. (43,875 TPA) at Khasra No.-1289/1, Village-Ramnagar, Tehsil-Rampur Baghelan, District-Satna (MP).(EIA Presentation)

This is case of Laterite and Limestone Mine. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-1289/1, Village-Ramnagar, Tehsil-Rampur Baghelan, District-Satna (M.P.) 4.85 Ha. The project requires prior EC before commencement of any activity at site.

The case was presented by the PP in the 08th SEAC II meeting dated 20/02/2016. It's being a case of major mineral, it was decided to consider this case as B-1 category and committee recommended to issue standard TOR prescribed by the MoEF&CC for conducting the EIA along with following additional TOR's:-

- 1. Inventory of operating / proposed mines within 2 Km around the said mine.*
- 2. Inventory of all sensitive receptors in 2 Km & 5 Km around the mine.*
- 3. Evacuation Plan on a map to be provided with transport route, required infrastructure and man-power.*
- 4. Any alternate route avoiding the nearby habitations.*
- 5. Compliance of consent conditions of M. P. Pollution Control Board from concerned Regional officer.*

PP has submitted EIA vide letter no.-23/03/2017 which was forwarded by the SEIAA vide letter no.-5683, dated-25/03/2017 which was placed before committee in 71st SEAC-II meeting dated-10/04/2017 wherein it was recorded that The Project Proponent (PP) was not present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. A representative of the PP requested that due to some unavoidable circumstances the PP could not come to Bhopal and requested that their project should be heard in the meeting scheduled on 12/04/2017. Committee decided that request of PP's representative can be considered if time permits on 12/04/2017 for their presentation after the scheduled agenda otherwise case may be scheduled in the upcoming meetings of SEAC II.

The case was scheduled for presentation today, wherein neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. PP vide letter dated 02/05/2017 requested to give another chance for presentation as his EIA consultant and his team is unable to attend the meeting due to some genuine reason. Committee accept the request of the PP and decided to give another chance in subsequent SEAC meetings and even if the PP remains absent, the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

2. Case No. -5164/16 Shri Ashok Katare, M/s Associated Lime Company, Mission Chowk, District-Katni (MP). Prior Environment Clearance for Limestone Deposit in an area of 7.035 ha. (expansion from 58,000 to 2,08,778 TPA) at Khasra No. 61 and 63 at Village-Nanhwara, Tehsil-Vijayraghgarh, District-Katni (MP) (EIA Presentation)

This is case of Limestone Deposit. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site at Khasra No. 61 and 63 at Village-Nanhwara, Tehsil-Vijayraghgarh, District-Katni (MP) 7.035 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-5050, dated: 23/11/15, has reported that there are 09 more mines operating or proposed within 500 meters around the said mine with total area of 220.581 ha including this mine.

Earlier this case was scheduled in 25th SEAC-II meeting dated-17/05/2016 wherein it was recorded that: *The case was presented by the PP. It's being a case of major mineral, it was decided to consider this case as B-1 category and committee recommended to issue standard*

TOR prescribed by the MoEF&CC for conducting the EIA along with following additional TOR's:-

- 1. Inventory of operating / proposed mines within 2 Km around the said mine.*
- 2. Inventory of all sensitive receptors in 2 Km & 5 Km around the mine.*
- 3. Evacuation Plan on a map to be provided with transport route, required infrastructure and man-power.*
- 4. HI line is crossing the lease and thus this issue should be discussed in the EIA report.*
- 5. Compliance of consent conditions of M. P. Pollution Control Board from concerned Regional officer.*
- 6. Detailed plantation scheme with budgetary allocations be provided in the EIA report.*
- 7. Mine water management plan be provided in the EIA report.*

PP has submitted EIA vide letter no.-18/04/2017 which was forwarded by the SEIAA vide letter no.-285, dated-21/04/2017.

The case was scheduled for presentation today, wherein neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. PP vide letter dated 02/05/2017 requested to give another chance for presentation as his EIA consultant and his team is unable to attend the meeting due to some genuine reason. Committee accept the request of the PP and decided to give another chance in subsequent SEAC meetings and even if the PP remains absent, the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

3. Case No. 5545/17 M/s Satguru Cements Pvt. Ltd, 601/1, Airen Heights, Scheme No. 54, PU-3, Opposite C-21 Mall, A.B. Road, Indore, MP Prior Environment Clearance for Limestone Mine in an area of 6.773 Ha.. (7600 TPA ha.) (Khasra no. 160, 162, 203, 167, 168, 169) at Village- Ghursal, Tehsil - Gandhwani, Dist. Dhar (MP) (TOR)

This is case of Limestone Mine. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site at (Khasra no. 160, 162, 203, 167, 168, 169) at Village- Ghursal, Tehsil - Gandhwani, Dist. Dhar (MP) 6.773 ha. The project requires prior EC before commencement of any activity at site.

The case was scheduled for presentation today, wherein neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. PP vide letter dated 02/05/2017 requested to give another chance for presentation as his EIA consultant and

his team is unable to attend the meeting due to some genuine reason. Committee accept the request of the PP and decided to give another chance in subsequent SEAC meetings and even if the PP remains absent, the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

4. Case No. 5543/17 M/s Prathvi Infrastructure Pvt. Ltd, 18, Udyog Nagar, Newawar Road, Indore, MP – 452002 Prior Environment Clearance for Stone Quarry in an area of 20.0 Ha.. (1,00,000 cum per annum) (Khasra no. 62/1/1) at Village- Rangwasa, Tehsil - Depalpur, Dist. Indore (MP)

This is case of Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site at (Khasra no. 62/1/1) at Village- Rangwasa, Tehsil - Depalpur, Dist. Indore (MP) 20.0 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-401, dated: 23/03/17, has reported that there are 02 more mines operating or proposed within 500 meters around the said mine with total area of 23.00 ha including this mine.

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings and even if the PP remains absent, the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

5. Case No. 5536/17 M/s Rajendra Singh Kiledar Construction Pvt. Ltd, Bazar Chouk, Baishdehi, Dist. Betul, MP – 460001 Prior Environment Clearance for Sand Auction quarry in an area of 5.520 ha. (10300 cum per annum) (Khasra no. 434, 308) at Village- Barchhi, Tehsil - Amla, Dist. Betul (MP)

This is case of Sand Auction. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at (Khasra no. 434, 308) at Village- Barchhi, Tehsil - Amla, Dist. Betul (MP) 5.520 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide through Ekal

Praman-Patr letter no. 1263 dated: 19/08/16, has reported that there is no more mine operating or proposed within 500 meters around the said mine.

Earlier this case was scheduled in 71st SEAC-II meeting dated-10/04/2017 wherein it was recorded that: *“Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings and even if the PP remains absent, the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.”*

Today, this case was scheduled again for presentation wherein it is recorded that Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. PP was also absent in the 71st SEAC-II meeting dated-10/04/2017. Committee decided to give last chance to PP for making presentation in the subsequent meetings of SEAC after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

6. Case No. 5537/17 M/s Rajendra Singh Kiledar Construction Pvt. Ltd, Bazar Chouk, Baishdehi, Dist. Betul, MP – 460001 Prior Environment Clearance for Sand Auction quarry in an area of 9.330 ha. (9000 cum per annum) (Khasra no. 1) at Village- Sontalai, Tehsil - Amla, Dist. Betul (MP)

This is case of Sand Auction. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located (Khasra no. 1) at Village- Sontalai, Tehsil - Amla, Dist. Betul (MP) 9.330 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 1265 dated: 19/08/16, has reported that there is no more mine operating or proposed within 500 meters around the said mine.

Earlier this case was scheduled in 71st SEAC-II meeting dated-10/04/2017 wherein it was recorded that: *“Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings and even if the PP remains absent, the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.”*

Today, this case was scheduled again for presentation wherein it is recorded that Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. PP was also absent in the 71st SEAC-II meeting dated-10/04/2017. Committee decided to give last chance to PP for making presentation in the subsequent meetings of SEAC after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

7. Case No. 5520/17 Shri Tejram, R/o Village Salakhedi, Tehsil Ghattiya, Dist. Ujjain, MP. (SIA/MP/MIN/33324/2015). Prior Environment Clearance for Sand Quarry in an area of 12.50 ha. (3750 cum per annum) (Khasra no. 988) at Village- Chitawad , Tehsil - Mahidpur, Dist. Ujjain (MP)

This is case of Sand Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at (Khasra no. 988) at Village- Chitawad, Tehsil - Mahidpur, Dist. Ujjain (MP) 12.50 ha. The project requires Prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer through Ekal Praman-Patr vide letter no. 1605 dated: 04/08/2016 has reported that there are no more mine operating or proposed within 500 meters around the said mine.

Earlier this case was scheduled in 72nd SEAC-II meeting dated-11/04/2017 wherein it was recorded that: *Today, this case was scheduled again for presentation wherein neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. PP was also absent in the 70th SEAC-II meeting dated-15/03/2017. Committee decided to give last chance to PP for making presentation in the subsequent meetings of SEAC after which the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.*

Today, the case was again scheduled for the presentation today but neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Earlier PP was also absent in the 72nd SEAC-II meeting dated-11/04/2017 & 70th SEAC-II meeting dated-15/03/2017. Committee decided that since sufficient opportunities have been given to the PP for appraisal and consideration of the project wherein PP remain absent, the

case shall be returned to SEIAA for delisting assuming that PP is not interested to continue with the project.

8. Case No. 5544/17 M/s Sidhant Minerals, Tikuriya Mohalla, Near Madiya Talab, Dist. Panna, MP – 488001 Prior Environment Clearance for Stone Quarry in an area of 7.45 Ha.. (50,411 cum per annum) (Khasra no. 313) at Village- Bansarai, Tehsil - Rajnagar, Dist. Chhatarpur (MP)

This is case of Stone Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at (Khasra no. 313) at Village- Bansarai, Tehsil - Rajnagar, Dist. Chhatarpur (MP) 7.45 ha. The project requires Prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer through Ekal Praman-Patr vide letter no. 563 dated: 06/03/2017 has reported that there are 02 more mines operating or proposed within 500 meters around the said mine with total area of 14.75ha including this mine.

Neither the Project Proponent (PP) nor his representative was present to explain the query which might be raised or to make any commitment which may be desired by the committee during the deliberation. Committee decided to call the PP in subsequent meetings and even if the PP remains absent, the case shall be returned to SEIAA assuming that PP is not interested to continue with the project.

DISCUSSION ON QUERY RESPONSE SUBMITTED BY PP OR THE PROJECT ISSUES RECEIVED FROM SEIAA / PENDING FROM A LONG TIME FOR WANT OF DESIRED INFORMATION

9. Case No.4517/15 Shri Tejinder Singh, Authorized Signatory, G-1, Sapna Chambers, 12/1, South Tukoganj, Indore (MP)-461001 Prior Environment Clearance for approval of Sand Quarry in an area of 10.00 ha. (1,75,000 cum/year) at Khasra No.-126, Village-Raipur, Tehsil-Hoshangabad, District-Hoshangabad (MP).

This is case of Sand Quarry. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No.-126, Village-Raipur, Tehsil-Hoshangabad, District-

Hoshangabad (MP) 20.500 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-2862 dated: 24/07/2015 has reported that there is 10 more mines operating or proposed within 1000 meters around the said mine with total area of 107.775 ha including this mine.

Earlier this case was scheduled in 54th SEAC-II meeting dated-14/10/2016 wherein it was recorded that:

Please refer the minutes of 20th SEAC meeting dated: 26/4/2016 wherein TOR was approved

As per the above, the TOR was issued to the PP vide letter no. 834 date: 13/5/2016

MP State Mining Corporation Limited, Bhopal vide their letter no.397 dated 09/08/2016 has also informed that it is a case of non-cluster as per GOI, MoEF&CC notification dated 01/07/2016 as this lease was sanctioned prior to the 09/09/2013. Concerned Mining Officer vide letter no. 473 dated 29/07/2016 has issued a certificate stating that above lease was sanctioned vide order no. F4-1/2010/12/01 dated 22/09/2010 and thus does not falls under the perview of cluster approach as per GOI, MoEF&CC notification dated 01/07/2016.

SEIAA vide letter no. 3173/SEIAA/16 dated 16/08/2016 and 3240/SEIAA/16 dated 26/08/2016 has also instructed to appraise such cases on priority as per GOI, MoEF&CC notification dated 01/07/2016 and thus committee decided that as per the above instructions of SEIAA, all such cases should be appraised on the priority on the basis the lease documents available in the file/representation submitted by the PP.

Case was presented by PP and their consultant. During presentation, it was observed that a representation vide letter dated 06/09/2016 is submitted which was forwarded by SEIAA vide letter no. 3513/SEIAA/16 dated 12/09/2016 along with. As per the representation, revised certificate is issued by the Conservator Forest, Hoshangabad, M.P., stating that Ratapani Abhayaran is at a distance of 9.20 kms (a Notified PA) from Khasra No. Earlier TOR was issued to this case on the basis of certificate issued by DFO, Hoshangabad, issued vide letter no. 3881 dated 15/04/2015 stating that no notified PA within 10 kms radius. Committee after deliberations decided that since revised certificate is issued by Conservator Forest, Hoshangabad, clearance from NBWL is therefore needed and thus PP was asked to apply online for NBWL clearance and a copy of the application may be submitted to SEAC for further appraisal of the project.

PP was also informed to submit above information vide letter no 1609 dated 06/12/2016 stating to submit the desired information and reminder was also given to the PP vide letter no. 72 dated 19/01/2017. PP so far has not submitted the desired informations and the case was placed before the committee. The committee observed that PP has neither submitted the desired information nor has requested for providing additional time to submit desired information and thus decided that this case may be recommended for delisting to SEIAA as per MoEF&CC OM No. F-11013/5/2009-IA-II (Part) dated 30/10/2012 as PP has not submitted the desired information.

10. Case No. 5134/16 Shri Tejendra Singh, M/s Digiana Industries Pvt. Ltd., Sub Lessee of M.P. State Mining Corporation Limited, G-1, M-3, Sapna Chambers, 12/1, South Tukoganj, Indore (MP)-452001 Prior Environment Clearance for River Sand Quarry in an area of 10.558 ha. (1,84,000 cum/year) at Khasra no.-126, Village-Raipur, Tehsil-Hoshangabad, District- Hoshangabad (MP)

This is case of River Sand mining. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site at Khasra no.-126, Village-Raipur, Tehsil-Hoshangabad, District-Hoshangabad (MP) 10.558 ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 1000 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no.-2864, dated: -24/07/15, has reported that there are 07 more mines operating or proposed within 1000 meters around the said mine with total area of -76.668 ha including this mine.

Earlier this case was scheduled in 54th SEAC-II meeting dated-14/10/2016 wherein it was recorded that:

Please refer the minutes of 21st SEAC meeting dated: 04/5/2016 wherein TOR was approved

As per the above, the TOR was issued to the PP vide letter no. 828 date: 13/5/2016

MP State Mining Corporation Limited, Bhopal vide their letter no.397 dated 09/08/2016 has also informed that it is a case of non-cluster as per GOI, MoEF&CC notification dated 01/07/2016 as this lease was sanctioned prior to the 09/09/2013. Concerned Mining Officer vide letter no. 474 dated 29/07/2016 has issued a certificate stating that above lease was

sanctioned vide order no. F4-1/2010/12/01 dated 22/09/2010 and thus does not falls under the perview of cluster approach as per GOI, MoEF&CC notification dated 01/07/2016.

SEIAA vide letter no. 3173/SEIAA/16 dated 16/08/2016 and 3240/SEIAA/16 dated 26/08/2016 has also instructed to appraise such cases on priority as per GOI, MoEF&CC notification dated 01/07/2016 and thus committee decided that as per the above instructions of SEIAA, all such cases should be appraised on the priority on the basis the lease documents available in the file/representation submitted by the PP.

Case was presented by PP and their consultant. During presentation, it was observed that a representation vide letter dated 06/09/2016 is submitted which was forwarded by SEIAA vide letter no. 3515/SEIAA/16 dated 12/09/2016 along with. As per the representation, revised certificate is issued by the Conservator Forest, Hoshangabad, M.P., stating that Ratapani Abhayaran is at a distance of 9.20 kms (a Notified PA) from Khasra No. 126. Earlier TOR was issued to this case on the basis of certificate issued by DFO, Hoshangabad, issued vide letter no. 3881 dated 15/04/2015 stating that no notified PA within 10 kms radius. Committee after deliberations decided that since revised certificate is issued by Conservator Forest, Hoshangabad, clearance from NBWL is therefore needed and thus PP was asked to apply online for NBWL clearance and a copy of the application may be submitted to SEAC for further appraisal of the project.

PP was also informed to submit above information vide letter no 1607 dated 06/12/2016 stating to submit the desired information and reminder was also given to the PP vide letter no. 44 dated 19/01/2017. PP so far has not submitted the desired informations and the case was placed before the committee. The committee observed that PP has neither submitted the desired information nor has requested for providing additional time to submit desired information and thus decided that this case may be recommended for delisting to SEIAA as per MoEF&CC OM No. F-11013/5/2009-IA-II (Part) dated 30/10/2012 as PP has not submitted the desired information.

11. Case No.-5273/2016 M/s Digiana Industries Pvt. Ltd, Shri Tejinder Singh, G-1 Sapna Chambers, 12/1 South Tukoganj, Indore (M.P.) (SIA/MP/MIN/9556/16). Prior Environment Clearance for Sand Deposit in an area of 10.55 ha. (184000 cum/year) at Khasra No. 126 at Village-Raipur, Tehsil - Hoshangabad, Dist. Hoshangabad (MP).

This is case of Sand Deposit. The application was forwarded by SEIAA to SEAC for appraisal. The proposed site is located at Khasra No. 126 at Village-Raipur, Tehsil -

Hoshangabad, Dist. Hoshangabad (MP) 10.55 Ha. The project requires prior EC before commencement of any activity at site.

PP has submitted a copy of approved Mining Plan, letter from Mining Officer certifying the leases within 500 meters radius around the site and requisite information in the prescribed format duly verified by the Tehsildar and DFO. Concerned Mining Officer vide letter no. 564 dated: 13/06/16 has reported that there are 06 more mines operating or proposed within 500 meters around the said mine with total area of 66.66 ha including this mine.

Earlier this case was scheduled in 54th SEAC-II meeting dated-14/10/2016 wherein it was recorded that:

The case was earlier discussed in the 40th SEAC-II meeting dated: 25/7/2016 wherein it was observed. The copy of above notification was made available to all the members of the committee for perusal. In the GOI, MoEF&CC notification dated 01/07/2016 it is stated that “A cluster shall be formed when the distance between the peripheries of one lease is < than 500 meter from the periphery of other lease in a homogeneous mineral area which shall be applicable to the mine leases or query license granted on and after 09/09/2013”.

Thus committee after deliberations decided that PP should submit revised mining officer certificate clearly stating the number of leases within 500 meters of the periphery of this lease on Khasra map showing the details of all the other leases and their relevant information in following format:

SEIAA vide letter no. 3173/SEIAA/16 dated 16/08/2016 and 3240/SEIAA/16 dated 26/08/2016 has also instructed to appraise such cases on priority as per GOI, MoEF&CC notification dated 01/07/2016 and thus committee decided that as per the above instructions of SEIAA, all such cases should be appraised on the priority on the basis the lease documents available in the file/representation submitted by the PP.

PP so far has not submitted the desired informations and the case was placed before the committee. The committee observed that PP has neither submitted the desired information nor has requested for providing additional time to submit desired information and thus decided that this case may be recommended for delisting to SEIAA as per MoEF&CC OM No. F-11013/5/2009-IA-II (Part) dated 30/10/2012 as PP has not submitted the desired information.

Following standard conditions shall be applicable for the mining projects of minor mineral in addition to the specific conditions:

Annexure- 'A'

Standard conditions applicable to Stone/Murrum and Soil quarries:

1. The amount towards reclamation of the pit and land in MLA shall be carried out through the mining department. The appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
2. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA
3. Transportation of material shall be done in covered vehicles.
4. Necessary consents shall be obtained from MPPCB and the air/water pollution control measures have to be installed as per the recommendation of MPPCB.
5. Curtaining of site shall be done using appropriate media.
6. The proposed plantation should be carried out along with the mining @45 trees per hectare and PP would maintain the plants for five years including casualty replacement.
7. Transportation shall not be carried out through forest area.
8. Appropriate activities shall be taken up for social up-liftment of the area. Funds reserved towards the same shall be utilized through Gram Panchayat.
9. PP will take adequate precautions so as not to cause any damage to the flora and fauna during mining operations.
10. PP should maintain a log book wherein daily details of water sprinkling and vehicle movement are recorded.
11. PP should also maintain a log book containing annual details of tree plantation and causality replacement.
12. The validity of the EC shall be as per the provisions of EIA Notification subject to the following: Expansion or modernization in the project, entailing capacity addition with change in process and or technology and any change in product - mix in proposed mining unit shall require a fresh Environment Clearance.
13. Mining should be done as per the submitted land use plan submitted by PP.

Standard conditions applicable for the sand Mine Quarries*

6. Transport vehicles will be covered with taurpoline to minimize dust/sand particle emissions.
7. For carrying out mining in proximity to any bridge and/or embankment, appropriate safety zone on upstream as well as on downstream from the periphery of the mining site shall be ensured taking into account the structural parameters, location aspects, flow rate, etc., and no mining shall be carried out in the safety zone.
8. No Mining shall be carried out during Monsoon season.
9. The depth of mining shall be restricted to 3m or water level, whichever is less.
10. No in-stream mining shall be allowed.
11. The mining shall be carried out strictly as per the approved mining plan and ensure that the annual replenishment of sand in the mining lease area is sufficient to sustain the mining operations at levels prescribed in the mining plan.
12. Established water conveyance channels should not be relocated, straightened, or modified.
13. If the stream is dry, the excavation must not proceed beyond the lowest undisturbed elevation of the stream bottom, which is a function of local hydraulics, hydrology, and geomorphology.
14. After mining is complete, the edge of the pit should be graded to a 2.5:1 slope in the direction of the flow.
15. PP shall take Socio-economic activities in the region through the 'Gram Panchayat'.
16. EC will be valid for mine lease period subject to a ceiling of 5 years.
17. Mining should be done as per the submitted land use plan submitted by PP.

Annexure- 'C'

Standard conditions applicable for the Khodu Bharu sand Mine Quarries*

1. Mining should be done only to the extent of reclaiming the agricultural land.
2. Only deposited sand is to be removed and no mining/digging below the ground level is allowed.
3. The amount towards reclamation of the land in MLA shall be carried out through the mining department; the appropriate amount as estimated for the activity by mining department has to be deposited with the Collector to take up the activity after the mine is exhausted.
4. PP shall be responsible for discrepancy (if any) in the submissions made by the PP to SEAC & SEIAA.
5. The mining activity shall be done manually.
6. Heavy vehicles shall not be allowed for removal of sand.
7. The sand shall be transported by small trolleys up to the main transport vehicle.
8. Transport vehicles will be covered with tarpoline to minimize dust/sand particle emissions.
9. No Mining shall be carried out during Monsoon season.
10. PP shall take Socio-economic activity in the region through the 'Gram Panchayat'.
11. EC will be valid for mine lease period/mine plan subject to a ceiling of 5 years.
12. The mining shall be carried out strictly as per the approved mining plan.
