



**Minutes of the 671<sup>st</sup> Meeting of SEIAA dated 01.04.2021**


- (1) This is a project pertaining to mining of Sand Quarry in an area of 6.0 ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National Park /Sanctuary etc. thus it is not attracted by the general conditions and falls under category 'B-1' by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine having valid lease period as per the provisions of M.P. State Sand Mining Policy – 2019 with production capacity of 1,20,000 cum per annum.
- (2) It was noted that PP has submitted a copy of approved Mining Plan, DSR report, information in the lease's within 500 meters radius around the site and other requisite information in the prescribed format duly verified in the Collector Office letter no. 595 dated: 20/02/2020 has reported that there are no more mines operating or proposed within 500 meters around the said mine.
- (3) The Mining Lease has been granted in favour of M/s K.P.Singh Bhadoria Contractor, E-46 A, Balvant Nagar, Thatipur, Dist. Gwalior, MP - 474002, by the Madhya Pradesh State Mining Corporation Limited, Bhopal vide letter no. vide letter no. kramank/ret/2020/590 Bhopal, dated -10/02/2020 as per the provisions of M.P. State Sand Mining Policy – 2019 over an area of 6.0 ha. The Mining Plan and Replenishment Study has been approved by Collector Dindori, vide L.No. 282/Khani/kha.yo./2020 Bhopal, dated 22/08/2020.
- (4) SEAC in its 490<sup>th</sup> SEAC meeting dtd. 16.3.2021 has recommended the case with 26 special conditions for issuance of EC.
- (5) It was noted that as per DFO, Dindori vide letter no. 1918 dated: 04/06/2020, the National Park/Sanctuary is not located within 10 Km., radius from the mining site. Hence, the General Conditions are not attracted. There is no forest boundary in less than 250 m distance from the ML area.
- (6) It was noted that the water requirement is 36 KLD (32 KLD Dust Suppression+2KLD Drinking + 2 KLD Green Belt which shall be met from river and hand pump.
- (7) It was noted that the Public Hearing was held on 18.02.2021 at Near Govt. High School Village Kamkomohniya, Tehsil - Dindori, Dist. Dindori MP under the Chairmanship of Upper Collector, Dindori .

**After detailed discussions and perusal of recommendations of 490<sup>th</sup> SEAC meeting dtd. 16.3.2021, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:**

- I. PP shall not start mining activity before execution of lease agreement.
- II. The production capacity shall be limited to the quantity as recommended by SEAC.
- III. The mining shall be carried out strictly as per the approved mining plan and ensure that the annual replenishment of sand in the mining lease area is sufficient to sustain the mining operations at levels prescribed in the mining plan.







- IV. No ramp will be allowed within the river basin to transport sand to the other bank. Transportation will be allowed on the bank side where the mineral is being excavated.
- V. The entire lease area should be properly fenced and boundary stones marked at the site.
- VI. No in-stream mining shall be allowed. The local authorities should ensure that the mining activity is confined only in the dry portion where sand is exposed.
- VII. Leaving the submerged area as non-mining zone as committed in PP.
- VIII. The depth of the pit shall be as per Approved Mining Plan.
- IX. Transportation of sand not allowed during opening & closing timing of the school located in village area.
- X. Transportation of sand shall be strictly carried out from outside the village area.
- XI. PP shall ensure compliance of the direction and provision made for sand mining methodology up to 5 ha. lease area as per the Notification 30.08.2019 issued by MP Mineral Resource Department, GoMP.
- XII. The mining shall be carried out strictly in accordance with the Sustainable Sand Mining Management Guidelines, 2016 and Enforcement & Monitoring Guidelines for Sand Mining, 2020 issued by the MoEF&CC.
- XIII. If the stream is dry, the excavation must not proceed beyond the lowest undisturbed elevation of the stream both which is a function of local hydraulics, hydrology and geomorphology.
- XIV. PP shall ensure to compliance of all the commitments made during public hearing and submit compliance report in every six month of the year.
- XV. No Mining shall be carried out during Monsoon season.
- XVI. Alternate transportation route should be decided in consultation with the local Gram Panchayat.
- XVII. Total 9000 saplings of suitable tree species i.e. Neem, Peepal, Bargad, Amla, Jamun, Imli, Bel, Mahua etc. shall be planted by PP under plantation programme at Khasra No.516 Dist – kamkomohaniya in consultation with Gram Panchayat/ District Administration. PP shall also explore and identify the chunk of land in the area from revenue record to carry out plantation programme as proposed.
- XVIII. Over loading will be strictly prohibited.
- XIX. Water sprinkling will be done on the approach road on the regular basis.
- XX. PP must ensure the implementation of following activities under CER with all budgatory provision as committed in SEIAA :

PP shall ensure to construct wind breaking wall of 04 m to avoid fugitive emission and along the wind breaking wall with tall tree in 03 rows plantation shall be planted towards the solar plants located around approx 200 m. distance from mining site. It will also ensure to carry out dense plantation on Govt. land available between the solar plant and ML boundary.
- XI. PP shall ensure to construct garland drain with settling tank all around the lease area and regular cleaning & maintenance shall also be carried out by PP.

The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine having valid lease period as per the provisions of M.P. State Sand Mining Policy – 2019 with production capacity of 10,800 cum per annum.
- (2) It was noted that PP has submitted a copy of approved Mining Plan, DSR report, information in the lease's within 500 meters radius around the site and other requisite information in the prescribed format duly verified in the Collector Office (Ekal Praman-Patr) letter no. 454 dated: 24/07/2020 has reported that there are 01 more mines operating or proposed within 500 meters around the said mine with total area of 28.90 ha., including this mine.
- (3) The Mining Lease has been granted in favour of M/s Power Mech Projects Limited, by the Madhya Pradesh State Mining Corporation Limited, Bhopal vide letter no. kramank/ret/2020/546 Bhopal, dated -01/02/2020 as per the provisions of M.P. State Sand Mining Policy – 2019 over an area of 3.19 ha. The Mining Plan and Replenishment Study has been approved by DGM, Bhopal vide L.No. P. Kramank 7497/Mining Plan cell-1/N. 

- (4) SEAC in its 488<sup>th</sup> SEAC meeting dtd. 10.3.2021 & 493<sup>rd</sup> SEAC meeting dtd. 23.3.2021 has recommended the case with 16 special conditions for issuance of EC.
- (5) It was noted that as per Collector Office, (Ekal Praman-Patr) Bhind vide letter no. 454 dated: 24/07/2020, the National Park/Sanctuary is not located within 10 Km., radius from the mining site. Hence, the General Conditions are not attracted. There is no forest boundary in less than 250 m distance from the ML area.
- (6) It was noted that the water requirement is 3 KLD (1 KLD Sprinkling + 0.5 KLD Drinking + 0.5 KLD Plantation + 1 KLD washing & other ) which shall be met from Ground Water.

- I. PP shall not start mining activity before execution of lease agreement.

- IV. No ramp will be allowed within the river basin to transport sand to the other bank. Transportation will be allowed on the bank side where the mineral is being excavated.
- V. The entire lease area should be properly fenced and boundary stones marked at the site.
- VI. No in-stream mining shall be allowed. The local authorities should ensure that the mining activity is confined only in the dry portion where sand is exposed.
- VII. Leaving the submerged area as non-mining zone as committed in PP.
- VIII. The depth of the pit shall be as per Approved Mining Plan.
- IX. Transportation of sand not allowed during opening & closing timing of the school located in village area.





- XI. The mining shall be carried out strictly in accordance with the Sustainable Sand Mining Management Guidelines, 2016 and Enforcement & Monitoring Guidelines for Sand Mining, 2020 issued by the MoEF&CC.






Total start up water requirement is estimated as 765-1045 M<sup>3</sup> and after recycling & reuse of 415-480 M<sup>3</sup> of water, net fresh water requirement is estimated as 350-625 KLD, which will be sourced through river Narmada. 

- d. Industry shall install bag-house in boiler to maintain the emission level of particulate matter as per MPPCB/CPCB prescribed norms.
- e. Boiler ash shall be stored separately as per CPCB guidelines So that it shall not adversely affect the air quality, becoming air borne by wind or water regime during rainy season by flowing along with storm water.
- f. Bagasse ash and coal ash should be stored separately and reuse/recycle properly.

**7. Noise & Odor Environment & Management**

- a. Walls and ceilings of the concerned buildings should be lined with sound absorbing materials.

(MoEF&CC) amended (dtd 14/09/2016) the Environmental Impact Assessment (EIA) notification 2006, which governs the environmental clearance rules, and as a result, the five year validity for the project automatically became seven years.

- 2) Accordingly as per MoEF & CC, GoI Notification dtd. 14/9/2016 and office memorandum dtd. 11/6/2018 PP has applied vide proposal (Online proposal no. SIA/MP/THE/5032/2009) on 28/07/2020 and online acceptance on 15/12/2020 subsequently hard copy received in SEIAA office on 24/12/2020 for extension of Validity period of Environmental clearance.
- 3) As per the MoEF & CC, GoI Notification dtd 14/9/2016 period of validity may be extended by the regulatory authority concerned by a maximum period of three years if an application is made to the regulatory authority by the applicant within the validity period and within thirty days after the validity period of Environmental Clearance, such cases shall be referred to concerned Expert Appraisal Committee or State Level Expert Appraisal Committee. ....

After detailed discussion, it was decided that the case sent to SEAC regarding examine the availability of reject coal from the coal washery full fill the project requirement and accordingly extension of validity of environmental clearance can be extended upto three years or not. Copy to PP.

In view of above the case was considered in 491<sup>st</sup> meeting dtd. 18.03.21 and recorded that:-

"The case was presented by the PP and their consultant in response to above queries made in 486<sup>th</sup> SEAC meeting dated 26-02-21. PP vide dated 05/03/2021 has submitted the response of above quarries with complete chronology of the events since the grant of EC and till date with the copy of all the documents and relevant OMs in support of their claim, form-1, CTO, vesting order for coal, quantity of reject coal available and the same was presented before the committee.
