PP has not submitted desired information in the stipulated time even after given reminder letter. Hence, these cases are recommended by the committee for delisting in the light of MoEF&CC, O.M. File no. J-11013/5/2009-IA-II (Part), dated 30th October, 2012. The case was presented by the PP and their consultant in the 432nd SEAC meeting dated 18/05/20 wherein during appraisal it was observed by the committee that mine plan has been expired in the year 2018-19. PP submitted that they have already submitted the mine plan for approval and same will be submitted within 60 days time. Hence committee decided that PP shall submit revised mine plan duly approved by competent authority within 02 months time and then after this case shall be appraised. Qry. Letter issued vide letter No. 288 dated 23/06/2020. Reminder letter issued vide letter No. 482 dated 02/09/2020.PP vide letter dated NIL has submitted the mine plan which is not yet approved and retured back to PP by competent authority with certain observations vide letter dated 04/09/20. PP has not submitted the duly approved mine plan till date

As per above observation of SEAC, it has been decided to delist the case on the condition that if PP intends to present the case in SEIAA, it will then be relisted for appraisal. Copy to PP and all concerned.

PP requested to relist the case. After discussion it was decided to relist the case and send the technical file to SEAC for appraisal."

In view of above decision, the case is hereby relisted and the technical file is being sent for appraisal and you are requested to take the considered view on it.
