The case was presented by the PP and their consultant wherein during presentation and discussion it was observed as per the Google image that is at a pucca road is at a distance of approximately 25 meters towards south hence setback of 25m shall be maintained in lease from road side (by maintaining minimum 50m of area as non-mining zone from road side as per MMR 1996) and a windmill is at a distance of approximately 200 meters from lease towards North side, hence setback of additional 50m (by maintaining 250m of area as nonmining zone from windmill) shall be maintained. By considering this sensitivity and leaving setback as non-mining area no sufficient area is available for mining activity. Hence after detailed discussion committee recommends that in this situation, this case cannot be considered for grant of EC and case file be sent to SEIAA for further necessary action.

As per above recommendation of SEAC, it has been decided to reject the case considering environmental senstivity. Copy to PP and all concerned.."
