Committee observed that as per approved mine plan blasting is proposed thus committee after deliberation decided that in the light of NGT order in O.A. no. 304/2019 dated 21.07.2020 (if blasting is proposed minimum distance shall be 200 meters) this case cannot be considered for grant of EC being only 70 meters away from the habitations and as per approved mine plan blasting is proposed.."

After detailed discussion, it was decided to accept the recommendation of SEAC that the case cannot be considered for grant of EC and this case is hereby rejected. Copy to PP and all concerned.
