This is in reference to your application dated 01-05-10 seeking prior environmental clearance for the above project under the EIA Notification, 2006. The proposal has been appraised as per prescribed procedure in the light of the provisions under the EIA Notification, 2006 on the basis of the mandatory documents enclosed with the application viz., Form 1, 1A and misc. papers furnished to the State Expert Appraisal Committee.

It is interalia, noted that the project involves construction of High rise residential complex at village Pipliya Kumar, Teh- & Distt- Indore-M.P.

The Expert Committee after due consideration of the relevant documents submitted by the project proponent, forwarded the case for rejection, as per the provisions of Environmental Impact Assessment Notification, 2006 and its subsequent amendments.

The State Level Environment Impact Assessment Authority considered the above case in its 41<sup>st</sup> meeting held on 29/07/2010 and took the following decision.

“ The SEAC has observed that the land and the various permissions are in the name of M/s Ashok Hi-tech Builders (P) Ltd, whereas the application for Prior Environmental Clearance has been filed by Shri Navin Garg, President, M/s Pinnacle D Dreams, Indore. Hence SEAC has decided to send the case back to SEIAA for rejection”.

The Authority accepted the recommendations of SEAC and decided to reject the case.
