This is in reference to the proposal submitted in the SEIAA office to prescribe the Terms of Reference (TOR) for undertaking detailed EIA study for the purpose of obtaining Environmental Clearance in accordance with the provisions of the EIA Notification, 2006. For this purpose, the proponent had submitted online information in the prescribed format (Form-1) along with a Pre-feasibility Report and all supporting documents as per EIA Notification & its amendments.

 This is case of Environment Clearance for Construction of "M/s Vrindavan Construction is developing "Sage Golden Spring" Residential Apartment Located at Village: Damkheda, Patwari Halka No. 21, Tehsil – Huzur & District – Bhopal, Madhya Pradesh

2. The project is categorized as 'B-2' under item 8 (a) of Schedule-Gazette Notification dated Sep 14th, 2006 and subsequent amendments issued by MoEF, New Delhi on 01.12.09 and 04.04.2011.

The application was forwarded to SEAC for scoping so as to determine TOR to carry out EIA and prepare EMP for the project. The case was presented by the PP and their consultant Shri G. K. Mishra, M/s. Global Management and Engineering Consultant International, Jaipur (Raj.) in the SEAC- 583rd meeting dated 30.06.2022. After deliberation, it was observed as per Google image that PP has started constructed at site without prior Environment Clearance and therefore, its a violation of Environment Protection Act, 1986. Committee considering the recent Gol, MoEF & CC, OM F. No. 22-21/2020-IA.III dated 07.07.2021 & Notification S. O. 1030 (E), dated 8th March, 2018 recommends that case may be dealt as per the provisions laid down in this notification and the project may preparation of Reference for undertaking Environment Impact Assessment and preparation of Environment Management Plan on assessment of ecological damage,



remediation plan and natural and community resource augmentation plan and it shall be prepared as a independent chapter in the EIA report by the accredited consultant and the collection and analysis of data for assessment of ecological damage, preparation of remediation plan and natural and community resource augmentation plan shall be done by an environmental laboratory accredited by the National Accreditation Board for Testing and

After presentation, committee decided to recommend standard TOR prescribed by MoEF&CC with additional TOR. After the recommendation of SEAC the case was considered in 736th SEIAA meeting dtd.12.07.2022 and decided to approve the ToR as recommended by SEAC in 583rd meeting held on 30.06.22 and standard TOR prescribed by the MoEF&CC for conducting the EIA along with following additional TOR's and general

1. Project description, its importance and the benefits.

2. On the south-west side of the project area, a natural drain is in existence which shall not be diverted in any case. Alos its protection plan with 30 meters setback (as no development zone) from HFL shall be discussed in the EIA report.

3. If any demolition works are proposed, the details of C&D wastes shall be properly addressed in the EIA report.

4. No tree is falling proposed for which a written commitment shall be submitted.

5. Water and waste water details (water requirement for residents, staffs and for floating population etc.) shall be provided as suggested by the committee during

6. Green Building concepts (Status of GRIHA rating or IGBC rating) shall be adopted (minimum silver rating as submitted during TOR presentation) and their details shall be submitted with EIA report.

7. One common convenience facility shall be provided for supporting staff and details shall be discussed in the EIA report.

8. Status report of constriction took place so far, possession given to how many

9. Detailed plantation scheme with proposed species shall be discussed in the EIA

10. Furnish details of CO2 emission & quantification from different sources as DG sets and their management plan w.r.t. carbon foot print.

11. Provision of additional exit gate in the proposed project, at the time of emergency.

12. Fire NOC to be taken from the concerned department and submitted with EIA.

13. Under energy conservation plan detail-out solar light erection panels.

14. Project site detail (location, toposheet of the study area of 10 Km, coordinates, Google map, layout map, land use, geological features and geo-hydrological status of the study area, drainage.

15. Land use as per the approved Master Plan of the area, permission/approvals required from the land owning agencies, Development Authorities, Local Body, Water Supply & Sewerage Board etc.

16. Land acquisition status, R & R details (if any).

- 17. Baseline environmental study for ambient air (PM10, PN2.5, SO2, NOx & CO), water (both surface and ground), noise and soil for one month (except monsoon period) as per MoEF & CC/CPCB guidelines at minimum 5 locations in the study
- 18. Details on flora and fauna and socio-economic aspects in the study area.

19. Likely impact of the project on the environmental parameters (ambient air, surface and ground water, land, flora and fauna and socio-economic, etc.)

20. Sources of water for different identified purpose with the permissions required from the concerned authorities, both for surface water and the ground water (by CGWA) as the case may be, Rain water harvesting, etc.

21. Waste water management (treatment, reuse and disposal) for the project and also



- 22. Management of solid waste and the construction & demolition waste for the project vis-à-vis the Solid Waste Management Rules, 2016 and the Construction & Demolition Rules, 2016.
- 23. Energy efficient measures (LED lights, solar power, etc) during construction as well as during operational phase of the project.
- 24. Assessment of ecological damage with respect to air, water, land and other environmental attributes. The collection and analysis of data shall be done by an environmental laboratory duly notified under the Environmental (Protection) Act, 1986, or an environmental laboratory accredited by NABL, or a laboratory of a Council of Scientific and Industrial Research (CSIR) institution working in the field of environment.
- 25. Preparation of EMP comprising remediation plan and natural community resource augmentation plan corresponding to the ecological damage assessed and economic benefits derived due to violation.
- 26. The remediation plan and the natural and community resource augmentation plan to be prepared as an independent chapter in the EIA report by the accredited consultant.

The authority approve the ToR as recommended by SEAC and decided to issue additional TOR by incorporating following conditions for preparation of EIA report:

- c) प्राधिकरण द्वारा यह भी निर्णय लिया गया कि परियोजना प्रस्तावक/सलाहकार पर्यावरण प्रभाव आकलन प्रतिवेदन में प्रस्तावित परियोजना के कारण पर्यावरण पर पड़े प्रतिकूल प्रभाव का विस्तृत अध्ययन करेगा। साथ ही इनके प्रतिकूल प्रभाव को समाप्त करने के लिये उपचार योजना प्रस्तावित करेगा।
- d) प्रतिवेदन में निर्मित भवन का खुला स्थान (MOS) Front, Side & Back MOS की वास्तविक माप कार्य स्थल पर क्या है उसे मानचित्र में संलग्न करेगा। साथ ही नगर निगम, भोपाल, भवन निर्माण के पूर्व ली गई भवन अनुज्ञा एवं मानचित्र, संचालनालय नगर तथा ग्राम निवेश, भोपाल से स्वीकृत ले–आउट एवं पत्र का पठनीय मानचित्र संलग्न करेगा।

- f) Study the socio-economic condition of the project area and its surrounding and their impact on the project design and operation.
- g) Looking to the increase the use of electrical vehicle in recent future, provision for the installation of sufficient number of electrical charging port should be made in the proposed site. This point should be specifically discussed and deliberated in the proposed EIA.
- h) Project proponent shall explore feasibility to install as maximum as possible solar power / lighting systems within premises.
- Project proponent shall submit calculation regarding total storm water received in the premises, potential of rain water harvesting and quantity to be harvested along with details of installed / proposed structures in EIA report.
- Assessment of ecological damage with respect to air, water, land and other environmental attributes. The collection and analysis of data



shall be done by an environmental laboratory duly notified under the environment (Protection) Act 1986, or an environmental laboratory accredited by NABL, or laboratory of a Council of Scientific and Industrial Research (CSIR) institution working in the field of

General Conditions

- The date and duration of carrying out the baseline data collection and monitoring shall be informed to the concerned Regional Officer of the M.P Pollution Control
- During monitoring, photographs shall be taken as a proof of the activity with latitude 2. & longitude, date, time & place and same shall be attached with the EIA report. A drone video showing various sensitivities of the project area and nearby area shall also be shown during EIA presentation.
- An inventory of various features such as sensitive area, fragile areas, mining / 3. industrial areas, habitation, water-bodies, major roads, etc. shall be prepared and furnished with EIA.
- An inventory of flora & fauna based on actual ground survey shall be presented. 4.
- Risk factors with their management plan should be discussed in the EIA report. 6.
- The EIA report should be prepared by the accredited consultant having no conflict of interest with any committee processing the case. 7.
- The EIA document shall be printed on both sides, as far as possible. 8.
- All documents should be properly indexed, page numbered. 9.
- Period/date of data collection should be clearly indicated.
- The letter /application for EC should quote the SEIAA case No./year and also attach a copy of the letter prescribing the TOR. 11.
- The copy of the letter received from the SEAC prescribing TOR for the project should be attached as an annexure to the final EIA/EMP report. 12.
- The final EIA/EMP report submitted to the SEIAA must incorporate all issues mentioned in TOR. 13.
- Grant of TOR does not mean grant of EC.
- The status of accreditation of the EIA consultant with NABET/QCI shall be specifically mentioned. The consultant shall certify that his accreditation is for the sector for which this EIA is prepared. If consultant has engaged other laboratory for carrying out the task of monitoring and analysis of pollutants, a representative from laboratory shall also be present to answer the site specific queries.
- On the front page of EIA/EMP reports, the name of the consultant/consultancy firm along with their complete details including their accreditation, if any shall be indicated. The consultant while submitting the EIA/EMP report shall give an undertaking to the effect that the prescribed TORs (TOR proposed by the projectproponent and additional TOR given by the MOEF & CC) have been complied with and the data submitted is factually correct.
- While submitting the EIA/EMP reports, the name of the experts associated with 16. involved in the preparation of these reports and the laboratories through which the samples have been got analyzed should be stated in the report. It shall be indicated whether these laboratories are approved under the Environment (Protection) Act, 1986 and also have NABL accreditation.
- All the necessary NOC's duly verified by the competent authority should be 18.
- PP has to submit the copy of earlier Consent condition /EC compliance report, whatever applicable along with EIA report.
- The EIA report should clearly mention activity wise EMP and CER cost details and should depict clear breakup of the capital and recurring costs along with the timeline for incurring the capital cost. The basis of allocation of EMP and CER cost

should be detailed in the EIA report to enable the comparison of compliance with the commitment by the monitoring agencies.

 A time bound action plan should be provided in the EIA report for fulfillment of the EMP commitments mentioned in the EIA report.

The name and number of posts to be engaged by the PP for implementation and

monitoring of environmental parameters should be specified in the EIA report.

EIA report should be strictly as per the TOR, comply with the generic structure as detailed out in the EIA notification, 2006, baseline data is accurate and concerns raised during the public hearing are adequately addressed.

23. The EIA report should be prepared by the accredited consultant having no conflict of interest with any committee processing the case.

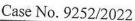
24. Actual measurement of top soil shall be carried out in the lease area at minimum 05 locations and additionally N, P, K and Heavy Metals shall be analyzed in all soil samples. Additionally in one soil sample, pesticides shall also be analyzed.

25. A separate budget in EMP & CER shall be maintained for development and maintenance of grazing land as per the latest O.M, of MoEF&CC issued vide letter F.No. 22-34/2018-IA. III, dated 16/01/2020.

PP shall submit biological diversity report stating that there is no adverse impact insitu and on surrounding area by this project on local flora and fauna's habitat, monthly compliance report.
 LPG gas shall be provided for

27. LPG gas shall be provided for camping labour under "Ujjwala Yojna .

- 28. In the project where ground water is proposed as water source, the project proponent shall apply to the competent authority such as Central Ground Water Authority (CGWA) as the case may be for obtaining, No Objection Certificate (NOC).
- 29. Under CER scheme commitments with physical targets shall be included in EIA report for:
 - Activities such as solar panels in school, awareness camps for Oral Hygiene, Diabetes and Blood Pressure, works related to plantation (distribution of fruit & fodder bearing trees) vaccination, cattle's health checkup etc. in concerned village shall be proposed.
 - No fuel wood shall be used as a source of energy by mine workers. Thus proposal for providing solar cookers / LPG gas cylinders under "Ujjwala Yojna" to them who are residing in the nearby villages, shall be considered.
 - PP's commitment that activities proposed in the CER scheme will be completed within initial 03 years of the project and in the remaining years shall be maintained shall be submitted with EIA report.
- 30. Under Plantation Scheme commitments with budgetary allocations shall be included in EIA report for :
 - Comprehensive green belt plan with commitment that entire plantation shall be carried out in the initial three years and will be maintained thereafter with causality replacement. Proposal for distribution of fruit bearing species for nearby villagers shall also be incorporated in the plantation scheme and for which a primary survey for need assessment in concerned village shall be carried out.
 - Commitment that plantation shall be carried out preferably through Govt. agency (such as Van Vikas Nigam / Van Samiti under monitoring and guidance of Forest Range officer with work permission from DFO concerned / Gram Panchayat / Agricultural department or any other suitable agency having adequate expertise as per the budgetary allocations made in the EMP.
 - Commitment that high density plantation (preferably using "Miyawaki Technique or WALMI technique) shall be developed in 7.5m barrier zone



left for plantation through concern CCF (social forestry) or concerned DFO or any other suitable agency.

PP shall explore the possibility for plantation in adjoining forest land in consultation with concerned DFO and commensurate budget shall be transferred for plantation to DFO.

Where ever Aushadhi Vatika (Medicinal Garden) is proposed by PP,

minimum 50 saplings be planted considering 80% survival.

Adequate provisions of water for irrigating plantation shall be made by PP. FOR PROJECTS LOCATED IN SCHEDULED (V) TRIBAL AREA, following should be studied and discussed in EIA Report before Public Hearing as per the instruction of SEIAA vide letter No. 1241 dated 30/07/2018.

Detailed analysis of availability and quality of the drinking water resources available 2.
