This has reference to your application dated 01-10-2008 seeking prior environmental clearance for the above project under the EIA Notification, 2006. The proposal has been appraised as per prescribed procedure under the provisions of EIA Notification, 2006 on the basis of the mandatory documents enclosed with the application form by the State Expert Appraisal Committee.

It is interalia, noted that the project involves putting up a 10 MW Biomass based power project at village Sanver, Teh- Sonkachh Distt- Sehore- M.P.

The Expert Committee after due consideration of the relevant documents submitted by the project proponent and additional clarifications furnished in response to its observations has recommended the case for exemption, as per the provisions of Environmental Impact Assessment Notification, 2006 and its subsequent amendments. SEIAA considered the case in its 39th meeting held on 26th June, 2010 and took the following decision:-

The above case was recommended by SEAC for exemption as the above case is a bio-mass based power project having a capacity of less than 15 MW.

It was decided by the SEIAA to ask for a commitment letter from project proponent stating that the auxiliary fuel will not be used more than 15%. The same has been submitted by the proponent.

SEIAA accepted the recommendation of SEAC and decided to exempt the above case.
