- **1. Case no. 230/2008** M/s Indore Entertainment World Pvt Ltd, 6th Floor, Treasure Island II, Tukoganj, Main Road, Indore M.P, Residential Township project at Kanadia, Indore- M.P.

The Authority scrutinized the documents submitted by the Project Proponent and as per information provided in form 1 the project site is 4 km away from Indore railway station. Thus it falls under critically polluted area. The notification of MoEF, GOI dated 14th September 2006, mentions 'General Condition', and According to it any project or activity specified in Category `B" will be treated as Category `A' if located in whole or in part within 10 km from the boundary of - (ii) critically polluted areas as notified by CPCB from time to time. Hence, the project is treated as Category `A' and a decision for Prior Environmental Clearance may be taken by MoEF, GOI. The Authority decided to return the case along with all the documents to Project Proponent.

2. Case no. 477/2009 - Shri Nimish Arora, Director, M/s Aarone Developers Pvt Ltd, 6th Floor, Office Tower, Select City Walk, A-3, District Centre Saket, New Delhi – 110 017.

The Authority while scrutinizing the document (as per information given in the Town & Country Planning Letter No. T&CP/ADMT/2008/Indore/3323 dt. 23.6.08 Pt.no. 11 regarding water supply) the authority came to conclusion that the project is either in Indore Municipal Corporation or in adjoining area which is within prescribed distance of 10 km, which is critically polluted area. The notification of MoEF, GOI dated 14th September 2006 mentions 'General Condition'. According to it, any project or activity specified in Category `B" will be treated as Category `A' if located in whole or in part within 10 km from the boundary of - (ii) critically polluted areas as notified by CPCB from time to time. Hence, the project would be treated as Category `A' and a decision for Prior Environmental Clearance may be taken by MoEF, GOI. The Authority decided to return the case along with all the documents to Project Proponent.
