Ref: This office letter No. 25-26 dt. 21/04/2009.

- 1. This has reference to your application dated 11/02/2010, 05/05/2010, 23/12/2010, 05/01/2011, 22/01/2011 and 03/02/2011 for amendment of the prior Environmental Clearance earlier issued to you vide above referred letter of this office, in which SEIAA has accorded Environmental Clearance to 1x70 MW unit only. The Project Proponent was to get clearance of the other unit of 70 MW after getting the possession of the remaining land.
- 2. The proponent has submitted an application for grant of EC for change in configuration from 2X70 MW (Total 140 MW) to 3X45 MW (Total 135 MW) because of unavailability of the 70 MW units readily. It was submitted by the PP that the industry may be allowed to put up 2X45 MW units in the available land (108.93 acres) and 1X45 MW unit may be allowed after procurement of remaining land. In this context the proponent has submitted the authenticated land ownership documents for the requisite land required to for the said production capacity.
- 3. The case was examined by the SEAC in its 65<sup>th</sup> meeting and was recommended for the amendment. Further the case was discussed in the 49<sup>th</sup> meeting of SEIAA.

4. Based on the submissions by the proponent and in continuation to the earlier prior Environmental Clearance the following change is made in the referred prior Environmental Clearance.

- 5. The terms and conditions mentioned in the Prior Environmental Clearance issued vide referred letter remain unaltered.
- 6. Proponent shall obtain permission from SEIAA before planning for the remaining 1x45 MW unit along with the land ownership documents (12 Acre) for the same.

This revised Prior Environmental Clearance shall be kept & read along with the earlier Prior Environmental Clearance issued to the proponent vide letter no. 25-26 dated 21/04/2009.
